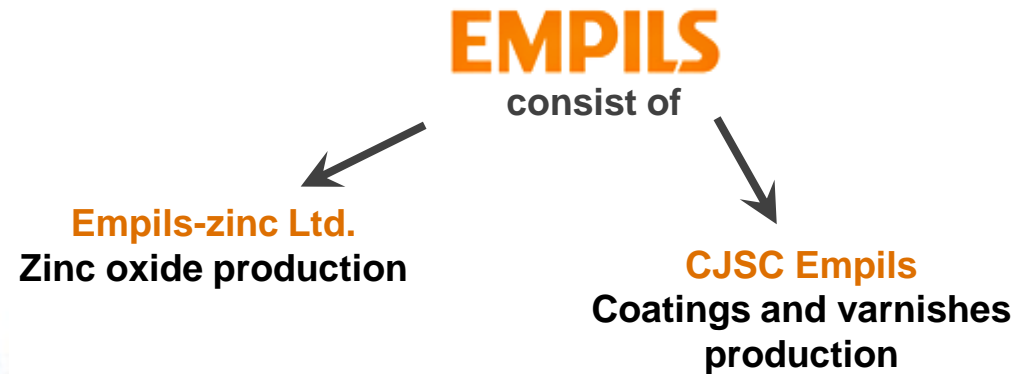

Empils-zinc Ltd. (Zinc Oxide production plant) belongs to Empils Corporation.

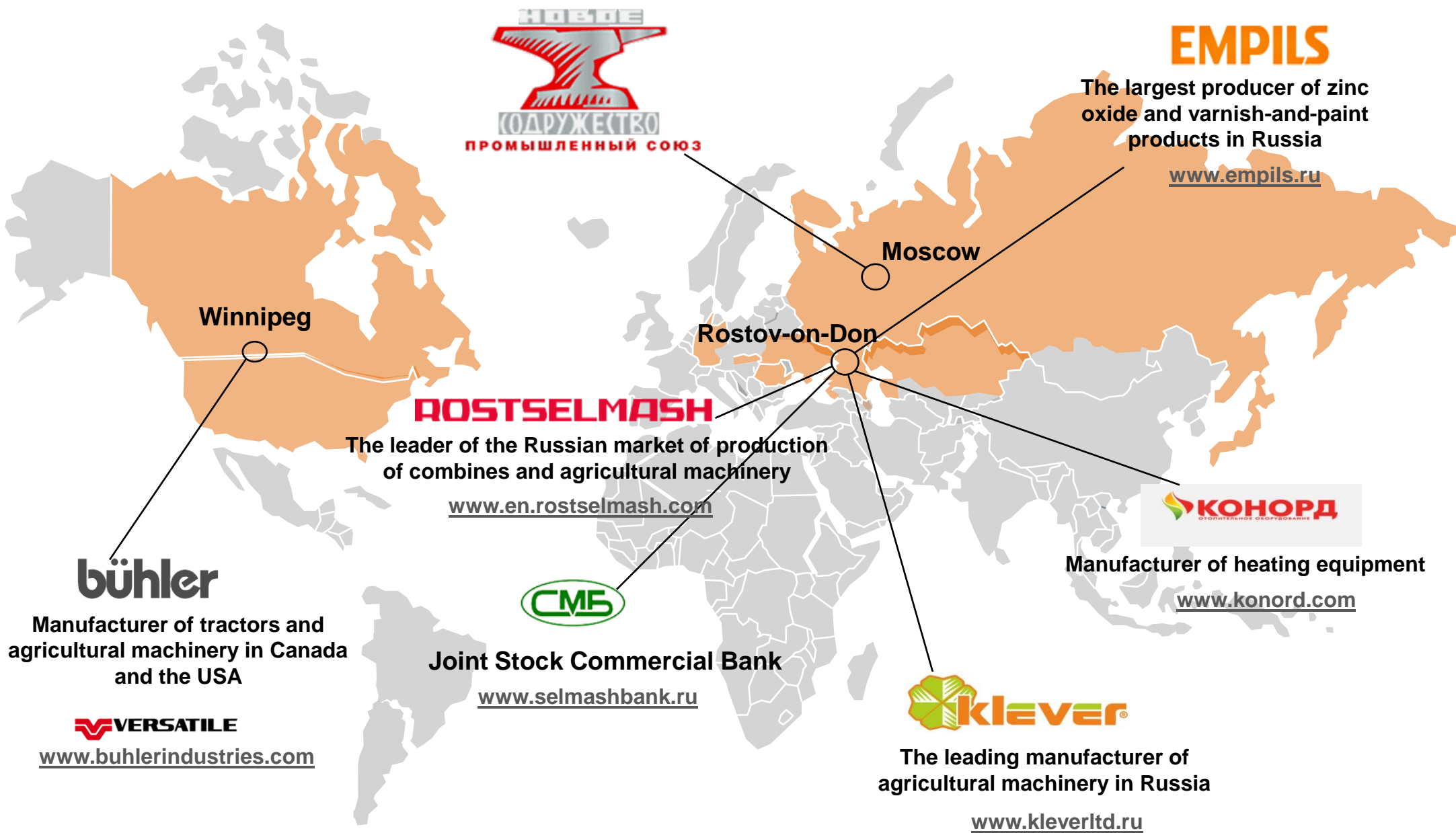
The Empils Corporation manufactures high quality decorative coatings and zinc oxide for consumers not only in Russia but also in the countries of CIS, Europe and Central Asia.

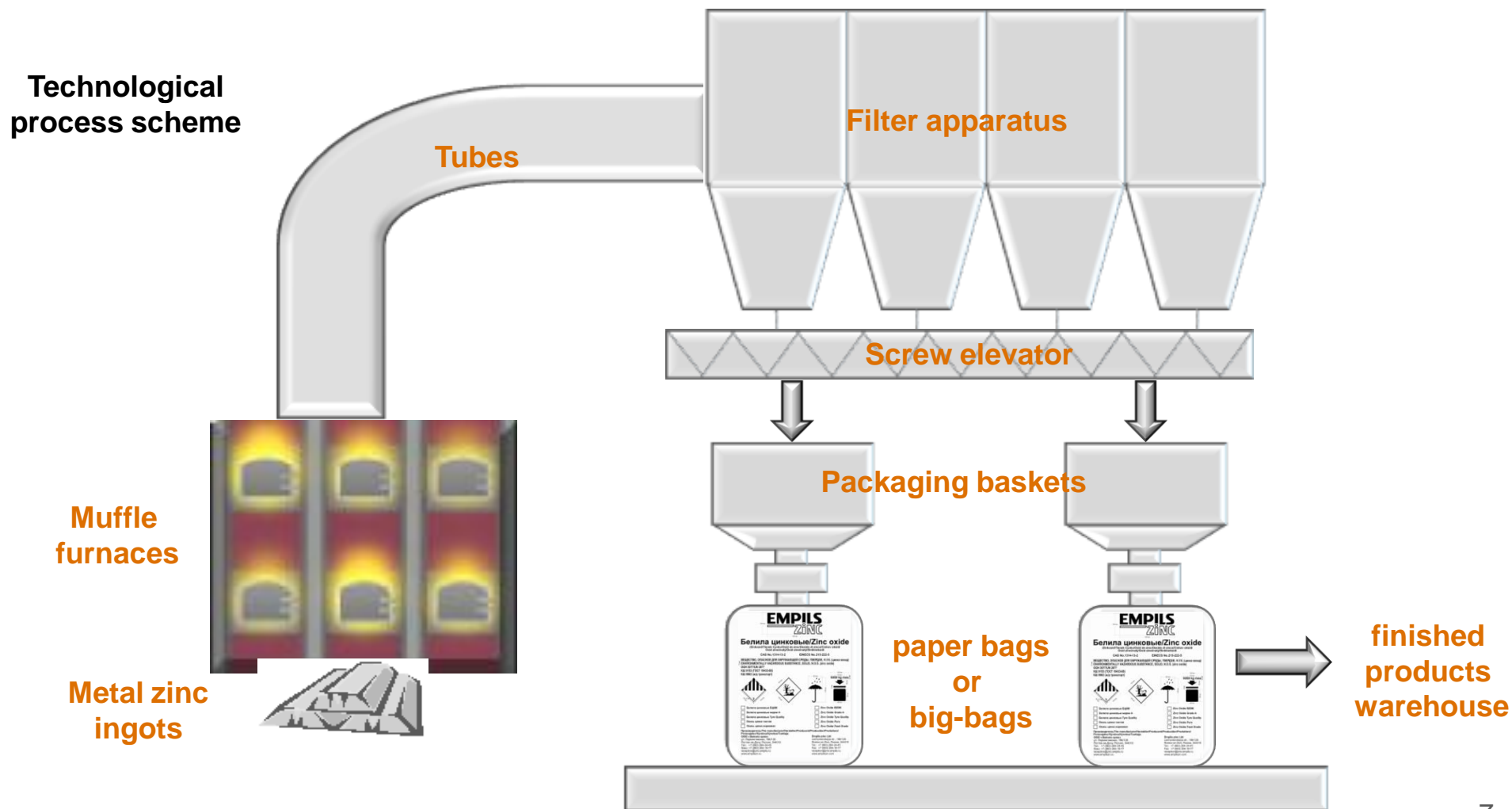

Every container (big-bag) is sealed, has a serial number and production shift.

Packaging on pallets is possible if necessary.

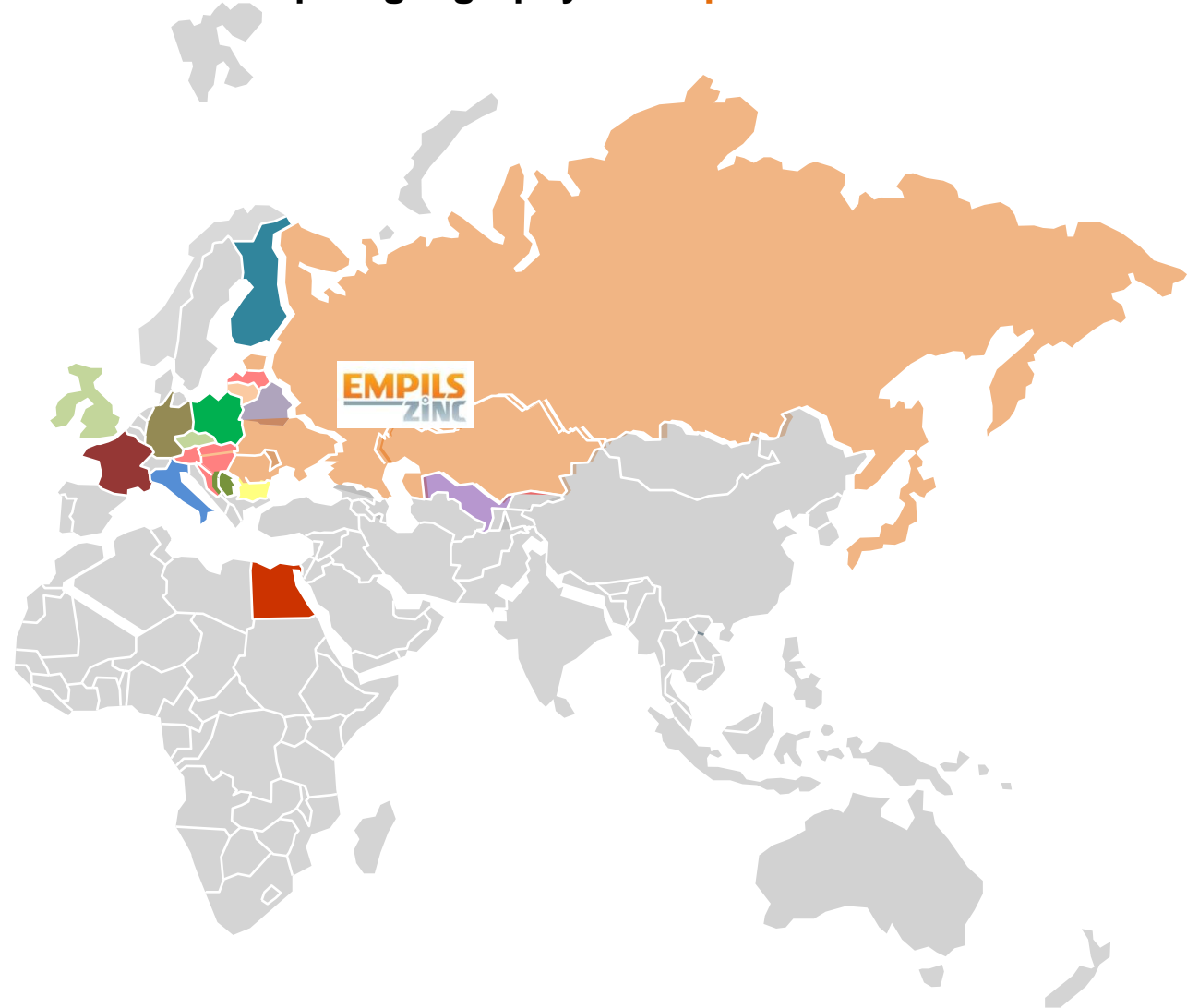
